Update on ATRC Consortium: Carolyn McGonagill & Tom Bauer State Funding

- Budget biggest concerns.
- This year there was 3% cut from Gov Barnes \$194,00 from \$200,000 allocated. Next year because of economic situation it will be harder.
- Commissioner maximized State funds to bring down Federal funds. Dept of Labor collaboration.
- Need last proposal sent to Larry Beck that gave recommendations. Send letter to Joy and Christopher.
- Build into contracts the ATRCs are serving individuals where billing has already taken place. Concern of DOL. Double dipping.
- Need to resolve issues with Pat Joseph.
- From conversations with Susan Sherman, ATRC/Reboot services currently being provided but not reimbursed after consideration by Dept of Labor, could possibly be incorporated in outsource manual or fee for services schedule.
- E-text Bill for College. Carolyn and Tom Representing Consortium at the Co Age Priority issue Meeting. The consortium will be presented under their budget issues.
- They will pick one additional budget item due to carryover from last year. Usually takes five years for recognition to come forward. We are in year three.

Federal Funding

- Consortium members will have to work hard in getting the Tech Act reauthorization of Fed funding or we will be in big trouble.
- ATAP Association of TA Projects dues are about \$1,000.

- Appropriations Bill Senate version 26.8 million, House version 11.1 million. Jack Kingston on appropriations touch base with him soon as possible.
