We can...

- Provide product information we can share what we know or do some research to help you find what you need for an individual.
- Provide virtual demonstration of a product that you might be considering.
- Provide virtual training on a product that you are trialing or have purchased.
- ▶ Identify AT resources to borrow from TFL to try before buying, or we can connect you to a vendor that provides loans.

Ways we can help with knowldege...

We can

- Consult with teachers or other professionals on specific individual needs.
- Consult with IEP team members prior to an IEP meeting as to AT that is appropriate to help meet the student's educational or transition goals.
- Attend an IEP meeting virtually, just being another resource at the table.
- Review video observations, and provide recommendations. Short reports may be available.
- Provide AT team professional development.
- Our goal is to help you meet individual needs for AT prior to the need for an independent evaluation!

We Can Provide Evaluations

- Sometimes it is necessary that an independent evaluation be conducted by a qualified person, with extensive knowledge of Assistive Technology.
- If we have not been able to meet the needs of the individual student virtually, we can travel to your site and conduct an evaluation.
 - ▶ 1. Your district must register with AMAC. This can be done online and does not cost anything.
 - ▶ 2. A school or a parent can request an evaluation, but the other will be contacted. Our goal is to be collaborative. We will ask to preview the student's current IEP, psychological, and any other pertinent evaluations prior to the AT eval.
 - ▶ 3. If we have been working with you prior to the request for an evaluation, all of what has been done can be useful in preparation for the evaluation.
 - ▶ 4. We will schedule a time for the eval. Face-to-face meetings may have a longer wait time...
 - ▶ 5. We will conduct the eval and generate a written report.
